

List of Documents (original and three sets of self-attested photocopies) required while reporting for MBBS admission at AIIMS, Bhopal:

At the time of admission, candidate is required to submit following documents in original; failure to do so may result in cancellation of claim for admission. Candidates are also required to submit three self-attested photocopies of each of these documents.

1. Rank letter / counseling letter.
2. Seat allotment letter issued during the counseling held at AIIMS, Delhi from **3rd-6th July 2017**.
3. For a proof of date of Birth: Class Xth Certificate or School / College Leaving Certificate or Certificate of Domicile / Nationality Certificate bearing date of birth.
4. Passing certificate and statement of marks of class XIIth examinations from the Board from which he/she passed the 10+2 or equivalent Examination showing that he/she has secured 60% or more marks (50% in case of SC/ST/Orthopaedic Physically handicapped candidates) in aggregate in English, Physics, Chemistry and Biology..
5. Category certificate in prescribed format in case of candidates claiming seat under reserved categories viz. OBC/SC/ST/OPH category.
6. Transfer / Migration Certificate from the Institution in which you had studied last (if not issued by the school last studied, may be submitted at later date).
7. An affidavit in the format (as per Annexure-I), signed by you and countersigned by your parent/guardian in the presence of Notary Public on a non-judicial stamp paper of Rs. 10/- or above.
8. Conduct and Character Certificate issued by the Principal of the school / college last studied.
9. Copy of the affidavit obtained by logging on to www.antiragging.in or www.amanmovement.org (Institute Phone number: 0755-2672317, required to fill the affidavit). The Director of AIIMS Bhopal is Prof. Nitin M Nagarkar and Dean is Prof. Rajesh Malik. These names may be required while submitting affidavit to anti-ragging sites. Name of the concerned police station is Baghsevania.
10. Ten recent passport-size coloured photographs (preferably identical to those affixed in the application form) with your name written on backside
11. Demand draft in favour of '**All India Institute of Medical Sciences Bhopal**' payable **at Bhopal for Rs. 5,856/-** (Rs. Five thousand eight hundred and fifty six only).
