3. For a proof of date of Birth: Class Xth Certificate or School / College Leaving Certificate or Certificate of Domicile / Nationality Certificate bearing date of birth.
4. A valid category certificate in prescribed format in case of candidates claiming seat under reserved categories viz. OBC/SC/ST category.
5. Statement of marks (Mark sheets) of MBBS examinations (1st to final year).
6. Certificate of Internship completion **by 30th July 2017**.
7. Permanent/Provisional Registration Certificate issued by MCI or State Medical Council.
8. Passing certificate of MBBS course. **(if not issued by the University last studied, may be submitted at later date. Candidate shall provide an undertaking on plain paper).**
9. Attempt Certificate.
10. Letter from the Institute (wherein the candidate pursued MBBS) stating MCI recognition of the college.
11. Transfer / Migration Certificate from the Institution / University in which candidate had last studied **(if not issued by the University last studied, may be submitted at later date. Candidate shall provide an undertaking on plain paper)**
12. An affidavit in the format (as per Annexure-I), signed by the candidate and countersigned by parent/guardian in the presence of Notary Public on a non-judicial stamp paper of Rs. 10/- or above.
13. Conduct and Character Certificate issued by the Principal of college (last studied).

15. Ten recent passport-size coloured photographs (preferably identical to those affixed in the application form) with name of the candidate written on backside


