Eligible candidates are invited to attend WALK-IN WRITTEN TEST for the following posts on contractual basis in the extramural research project funded by Indian Council of Medical Research (ICMR) titled "*Chronic disease risk factor surveillance in state of Madhya Pradesh with special focus on Tribal Population of the State*" under Dr. Arun M. Kokane, Principal Investigator and Professor of Community and Family Medicine at AIIMS Bhopal

<b>Desirable Qualifications</b>	:	Post graduate in health or related subjects with experience in community based projects
<b>Consolidated Pay</b>	:	Rs 18000/- per month Fixed All Inclusive
<b>Age Limit</b>	:	Below 30 years (as on the last date of application). Age relaxation as per GoI norms and may be given to deserving candidates by Competent Selection Committee
<b>Tenure</b>	:	13 months

**Note- Project involves field work in 10 districts of Madhya Pradesh and thus involves extensive travelling in state and candidates would not be stationed in Bhopal.**

1. Selection Venue: Department of Community and Family Medicine, 2nd Floor, Medical College Building, AIIMS Bhopal

No TA/DA will be paid for attending the walk-in-written / skill test.

2. Age Concession: Age will be calculated in completed years on the date of interview. Age relaxation is admissible in respect of SC/ST/OBC candidates, Retrenched Government Employees, Departmental Candidates (including projects), and ex-servicemen in accordance with the instructions issued by the Central Government from time to time. Age concession to the extent of services rendered in the research projects will also be admissible for experienced and skilled persons.
3. Date and Time of written test: **Wednesday 7<sup>th</sup> Feb. 2018, 10 AM to 11 AM**, followed by skill test this includes overall assessment on General Science, General Analytical ability and knowledge of concerned area. The Candidates shall **report at 9.45AM** to the Principal Investigator at selection venue.
4. The candidates shall report for appearing in the walk- in interview with following...
  - a. Duly filled application form
  - b. Self-attested photocopies of proof of date of birth (class 10th certificate/ school leaving certificate), eligibility qualification mark-sheets, degrees, experience certificate, caste certificate (if applicable), qualifying degree registration with statutory council (if applicable) and other relevant testimonials.

## TERMS & CONDITIONS

1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. Any misinformation detected at any stage will make the candidate liable for legal action. Permission to appear in the selection process does not approve the eligibility of the candidate. Even after qualifying the selection process the candidate may be rendered disqualified at the time of document verification if he / she does not fulfil essential eligibility criteria.
2. These appointments will be made from the staff strength sanctioned to the extra-mural project and employment in this extra-mural project will not vest any right to candidate for appointment within the sanctioned staff strength of AIIMS Bhopal or ICMR.
3. **Tenure:** The assignments are **purely on contract basis** for the period specified above. This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in AIIMS Bhopal or ICMR or for continued contractual appointment.
4. **Expiry of Contract:** The contract will automatically expire on completion of period specified above until it is renewed with mutual consent for the decided period. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
5. **Leave:** The leave entitlement of the appointee shall be governed in terms of the ICMR leave policy governing extramural / short term research projects as amended from time to time.
6. **Accommodation:** No hostel or any other accommodation will be provided by the Institute / Principal Investigator.
7. The candidate who is already in government service shall submit '**No Objection Certificate**' from the present employer at the time of walk-in-written test.
8. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
9. The candidate should bring along original certificates in support of his/her age, educational/ professional qualification, experience etc., two recent passport size colour photographs and a one set of self-attested photocopies of the relevant documents failing which he/she will not be allowed to participate in the interview or written test.
10. No travelling or other allowances will be paid to the candidate for appearing in written examination or for joining the post.
11. Canvassing of any kind will lead to disqualification.
12. Private practice of any type is prohibited.
13. He / She can be posted at any place as per the requirement of the project including rural areas / field sites.

14. He / She is expected to conform to the rules of conduct and discipline as applicable to the institute employees.
15. The decision of the competent authority regarding the selection of the candidate will be final and no representation will be entertained in this regard.
16. The candidate should not have been convicted by any Court of Law.
