**TERMS & CONDITIONS**

1. **Tenure:** The assignments are purely on contract basis initially for a period of twelve months.  
This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in the Institute or for continued contractual appointment.
2. **Remuneration:** The contract will entitle the contractual appointee to a consolidated monthly remuneration as mentioned above. The contractual appointee will not be entitled to any other allowances, financial benefits or concessions as admissible to Institute employees.
3. **Expiry of Contract:** The contract will automatically expire on completion of twelve months unless renewed with mutual consent for the decided period. The contractual appointment can be terminated at any time, by either side, by giving 30 days' notice or salary in lieu thereof.

4. The candidate who is already in Central/State Government / Semi Government/ Autonomous Institutions service shall submit '**No Objection Certificate**' from the present employer at the time of interview/document verification.
5. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.

The candidate should bring along original certificates in support of his/her age, educational/ professional qualification, experience etc., two recent passport size colour photographs and a two sets of self-attested photocopies of the relevant documents failing which he/she will not be allowed to participate in the interview/ document verification.
