Eligible candidates are invited to attend **WALK-IN-INTERVIEW** for the following post on contractual basis in the extramural research project funded by Department of Health Research / Indian Council of Medical Research (DHR-ICMR) titled **Burden of scrub typhus disease, its determinants and spatial distribution in Madhya Pradesh** under Dr. Shashank Purwar, Principal Investigator and Associate Professor of Microbiology at AIIMS Bhopal.

1.	Field Investigator	BVSc / BMLT from a recognized University with three years' work experience from a recognized institution or MVSc or Masters / MSc in Life Sciences after BMLT qualification.	Experience of working in field projects.

**Note:** Frequent travel to villages of Betul / Amla / Multai / Harda would be required for which expenditures would be reimbursed through project fund.

3. **Selection Venue:** Department of Microbiology, Ground Floor, Medical College Building, AIIMS Bhopal. No TA/DA will be paid for attending the walk-in-interview.
4. **Age Concession:** Age relaxation is admissible in respect of SC/ST/OBC candidates, Retrenched Government Employees, Departmental Candidates (including projects), and ex-servicemen in accordance with the instructions issued by the Central Government from time to time. Age concession to the extent of services rendered in the research projects will also be admissible for experienced and skilled persons.
5. **Date and Time of walk-in-interview:** 3:00 to 4:00 pm on 15<sup>th</sup> July 2019. The Candidates shall report at 1:00 pm to the Principal Investigator at selection venue.

6. The candidates shall report for appearing in the walk- in- interview with
  - a. Duly filled application form
  - b. Self-attested photocopies of proof of date of birth (class 10<sup>th</sup> certificate/ school leaving certificate), eligibility qualification mark-sheets, degrees, experience certificate, caste certificate (if applicable), qualifying degree registration with statutory council (if applicable) and other relevant testimonials.

8. **Application Fees: Nil**
9. **Short Listing:** Based on bio-data, the candidates may be short-listed for walk-in-interview. Candidates for walk-in-interview must bring printed copy of the application form, No objection certificate from the current employer (if in government service) and produce all relevant original documents in proof of details furnished in their application at the time of walk-in-interview.

## TERMS & CONDITIONS

1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. Any misinformation detected at any stage will make the candidate liable for legal action. Permission to appear in the selection process does not approve the eligibility of the candidate. Even after qualifying the selection process the candidate may be rendered disqualified at the time of document verification if he / she does not fulfil essential eligibility criteria.
2. These appointments will be made from the staff strength sanctioned to the extra-mural project and employment in this extra-mural project will not vest any right to candidate for appointment within the sanctioned staff strength of AIIMS Bhopal or ICMR-DHR.
3. **Tenure:** The assignments are purely on contract basis for the period specified above. This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in AIIMS Bhopal or ICMR/DHR or for continued contractual appointment.
4. **Expiry of Contract:** The contract will automatically expire on completion of period specified above until it is renewed with mutual consent for the decided period. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
5. **Leave:** The leave entitlement of the appointee shall be governed in terms of the ICMR leave policy governing extramural / short term research projects as amended from time to time.
6. **Accommodation:** No hostel or any other accommodation will be provided by the Institute / Principal Investigator.
7. The candidate who is already in government service shall submit '**No Objection Certificate**' from the present employer at the time of walk-in-interview.
8. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
9. The candidate should bring along original certificates in support of his/her age, educational/ professional qualification, experience etc., two recent passport size colour photographs and a one set of self-attested photocopies of the relevant documents failing which he/she will not be allowed to participate in the walk-in-interview.
10. The candidate applying in response to his advertisement should satisfy themselves regarding their eligibility in all respects.
11. No travelling or other allowances will be paid to the candidate for appearing in walk-in-interview or for joining the post.
12. Canvassing of any kind will lead to disqualification.
13. Private practice of any type is prohibited.
14. He / She can be posted at any place as per the requirement of the project including rural areas / field sites.
