Page 3, Bid opening date mentioned, 27.07.2018 at 10.00 , However on Page 9 – “e-Tender Schedule Date, Time and Place of Opening of Technical Bid Document : 27.07.2018 at 15.00 Hrs. in the office of Medical Superintendent, AIIMS Bhopal Hospital, Saket Nagar Bhopal- 462020 ”	On page 3 against S. No. 19 in the table, the time mentioned as 10.00 Hrs. shall be corrected to read as 15:00 Hrs.
2.	Page 6, Chapter 1 – 12 - “ Offline Submissions: The bidder is requested to submit the following documents offline to The Sr. Procurement-cum Store Officer, AIIMS, Bhopal (MP) – 462020 on or before the date & time of submission of bids specified in covering letter of this tender document, in a Sealed Envelope. The envelope shall bear (name of the work), the tender number and the words ‘DO NOT OPEN BEFORE’ (due date & time). However on Page. 9 – “e-Tender Schedule- Date, Time and Place of submission of Bids in the Sealed Envelope under two bid system: 26.07.2018 up to 14:00 Hrs. in the Tender box kept in the Office of the Medical Superintendent, AIIMS Bhopal Hospital, Saket Nagar-462 020 (MP) ”	On page 11 of Chapter 2 wherever “Office of Medical Superintendent “ is written the same shall be substituted to read as “Office of the Senior Procurement Cum Stores Officer”

3.	<p>Page 13 - Chapter 3 - 13 – <u>“The CBWTF provider shall transport the Biomedical waste in a dedicated covered vehicle to an authorized waste treatment Entity which is duly authorized by MPPCB</u> and meets the requirements of Biomedical Waste Management & Handling) Rule 2016.”</p> <p>No vehicle is approved by MPPCB; the vehicles are designed as per the guidelines given by CPCB.</p>	No change is required since they are in Sync with BMW guidelines.
4.	<p>Page 13, Chapter 3 - 17 – <u>“The CBWTF provider shall be required to establish bar coding</u> and global positioning system (GPS) for handling of bio-medical waste and to share the GPS coordinates with the first party”</p> <ul style="list-style-type: none"> - According to the bar-coding guidelines, any HCF having more than 30 beds should have its own electronic weighing machine and bar-coding. - Also, as per the BMW rules 2016, it is the duty of both CBWTF and HCF to implement the bar-coding system. - 	No change is required since they are in Sync with BMW guidelines.
5.	<p>Page 13, Chapter 3 – 22 – <u>“The monthly reimbursement on the basis of “actual bed occupancy”</u> will be calculated, verified by the AIIMS Bhopal Hospital Administration and shall be payable to the CBWTF provider by AIIMS Bhopal. The Bed Strength is current and it will increase in future. The increase in bed strength will be notified as and when it will increase. The payment to the CBWTF will be made on the basis of actual monthly bed strength.”</p> <ul style="list-style-type: none"> - The monthly reimbursement shall be calculated on the beds sanctioned in MPPCB and not on the actual bed occupancy. All over India the monthly reimbursement is being done on sanctioned bed strength, not on bed occupancy. 	No Change.
6	<p>Page 14, Chapter 4 - 8 – <u>“BASIS OF PER BED UNIT RATE FOR BMW SERVICES:-</u> The quoted per bed per day be payable to the CBWTF provider by AIIMS Bhopal. The current functional Bed Strength is 403 which will increase gradually as per targets. If the number of bed increases during the period of contract, the payment to the CBWTF provider will be made including such increase number from actual date. Payments shall be made against Invoice/ Bills in the name of “Director, AIIMS Bhopal, Saket Nager, Bhopal” in triplicate duly signed by authorized signatory of Service Provider Agency along with the copies of respective BMW</p>	No Change.

	<p>Services Registers maintained by the BMW Service Provider Agency or Ward/Point care area, where from the Bio Medical Waste Service Provider Agency will collect the Bio Medical Waste with the number of actual Beds during the month on date wise recorded (if applicable). The Bill along with requested records copies on each month shall be submitted by the Service Provider Agency to the designated Nodal officer nominated by the AIIMS Bhopal Hospital Administration for verification and after verification the Nodal officer will forward it to the Finance Department with their recommendations for release of admissible payment claim to the Agency for BMW services provided for number of Beds during the month by the Service Provider Agency.”</p> <p>- The monthly reimbursement shall be calculated on the beds sanctioned in MPPCB and not on the actual bed occupancy. All over India the monthly reimbursement is being done on sanctioned bed strength, not on bed occupancy.</p>	
7.	<p>Page 15, Chapter 4 - 8 – <u>“BASIS OF PER BED UNIT RATE FOR BMW SERVICES:- The quoted per bed per day price for providing Bio Medical Waste Management Services by CBTFW for AIIMS Bhopal offered by the CBWTF provider are inclusive of everything i.e. all expenditures and taxes like GST from First Party to the Bio Medical Waste Management & Disposable Facility at Second Party as per the detailed` scope of work given at “Schedule of Requirement” above shall be unchanged during the entire period of contact including extended period (if any)”</u></p> <p>The monthly reimbursement on “actual bed occupancy” basis will be calculated, verified by the AIIMS Bhopal Hospital Administration and shall be payable to the CBWTF provider by AIIMS Bhopal. The current functional Bed Strength is 403 beds and it is expected that bed strength during the period of Contract as per target. If the bed strength exceeds from 403 beds during the periods of contract, the monthly payment to the CBWTF provider will be made on approved rate on per bed basis from actual date “Vendors are free to quote slab rates for the service also.”</p>	No Change.

8.	<p>Page 19, ANNEXURE -1: (3): I - <u>Copy of Valid Labour Licence</u></p> <p>It may be stated that the scope of work does not require any manpower to be deployed in AIIMS Bhopal. We will be collecting Bio-Medical Waste from premises of AIIMS and the work of disposal and treatment of Bio-Medical Waste will be done at our site as per the BMW Management Rules 2016. Hence it is requested to waive off the submission of Labour Licence.</p>	It is being statutory requirement, can't be dispensed with.
9.	<p>Page 20, ANNEXURE -2: 1 – <u>“The monthly claim against actual Beds basis</u> will be calculated and verified by the Nodal Officer of AIIMS Bhopal and shall be payable to the Contractor by AIIMS Bhopal. The Current functional Bed Strength is 403 which will increase gradually depending upon the target of Institute. If in case, the more beds beyond the 300 Beds will be added at AIIMS Bhopal, the payment to the Agency will be made accordingly on monthly basis on their approved per Bed Rates.”</p> <p>The monthly reimbursement shall be calculated on the beds sanctioned in MPPCB and not on the actual bed occupancy. All over India the monthly reimbursement is being done on sanctioned bed strength, not on bed occupancy.</p>	No Change.
10.	<p>Page 26, Annexure – 6 : <u>Vendor Registration Form:</u></p> <ul style="list-style-type: none"> - GST Registration Number - Tax Identification Number (TIN) - Service Tax Number <p>-Since, bio medical waste disposal services are exempted from the above, the following details should not be mandatory.</p> <p>-We are working for AIIMS Bhopal since August 2014 and we are already a registered vendor and our PFMS unique code is VAMPBP00006475. Please clarify whether we need to submit Annexure VI, along with technical bid.</p>	Those already registered under PFMS, the proforma of Annexure -VI should be submitted by quoting registration number at prominent place.
