1. Contractors who fulfill the following requirements shall be eligible to apply. Joint ventures are not accepted.
  - a. Should have satisfactorily completed the works as mentioned below during the last Seven years ending **previous day of last date of submission of bids**.
    - i. One similar work each costing not less than ₹ 16.41 Lakhs
    - ii. Two similar works each costing not less than ₹ 12.31 Lakhs
    - iii. Three similar works costing not less than ₹ 8.20 Lakhs.
    - iv. Similar work means **“Operation and maintenance of Fire Alarm & PA System”**  
The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of submission of bids.
  - b. Should have had average annual **financial turnover** of ₹ 10.00 Lakh during the immediate last three consecutive financial years. (Scanned copy of Certificate from CA to be uploaded).
  - c. Should not have **incurred any loss** in more than two years during the last five years ending **31<sup>st</sup> March 2018**.

2. The intending bidder must read the terms and conditions of **CPWD-7** carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.

4. 6. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.
7. The intending bidder must have valid *class-I/Class-II/Class-III digital signature* to submit the bid.
8. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
9. Contractor can upload documents in the form of **JPG** format and **PDF** format.
10. **Certificate of Financial Turn over:** At the time of submission of bid contractor may upload Affidavit/ Certificate from **C.A.** mentioning Financial Turnover of last 3 years or for the period as specified in the bid document and further details if required may be asked from the contractor after opening of technical bids. There is no need to upload entire voluminous balance sheet.
11. Contractor must ensure to quote percentage rate on total value of work with selection of ABOVE/ BELOW/ AT PAR. The column meant for quoting percentage rate in figures appears in "Yellow Color". In addition to this, while selecting Above/ Below / AT PAR, if the cell is left with AT PAR selection, the same shall be treated as "**0**" (**ZERO**) **Percent. However, if a tenderer quotes nil rates against each item in item rate tender or does not quote any percentage above / below on the total amount of the tender or any section / subhead in percentage rate tender, the tender shall be treated as invalid and will not be considered as lowest tenderer.**

The enlistment of the contractors should be valid on the last date of submission of bids. In case the last date of submission of bid is extended, the enlistment of contractor should be valid on the original date of submission of bids.

The work is estimated to **Cost of ₹ 20,51,532/-** This estimate, however, is given merely as a rough guide.

- 1.1 The authority competent to approve NIT for the combined cost and belonging to the major discipline will consolidate NITs for calling the bids. He will also nominate Division which will deal with all matters relating to the invitation of bids.
- 1.2 Intending bidder is eligible to submit the bid provided he has definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works of magnitude specified below:-

## 2. **Criteria of eligibility for submission of bid documents**

### 2.1. **Criteria of eligibility for non-CPWD contractors :**

- 2.1.1. One similar work each costing not less than **₹ 16.41 Lakh**
- 2.1.2. Two similar works each costing not less than **₹ 12.31 Lakh**
- 2.1.3. Three similar works each costing not less than **₹ 8.20 Lakh.**

In last 7 (Seven) Years ending previous day of Last date of submission of Bids.

- 2.2. The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of submission of bids. This is applicable for 2.1 (This is not applicable for CPWD enlisted contractors of appropriate class in composite category). Similar work means **“Annual operation & maintenance of Fire alarm & PA System.”**

**To become eligible for issue of bid, the bidders shall have to furnish an affidavit as under:-**

I/We undertake and confirm that eligible similar works(s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I/we shall be debarred for tendering in CPWD in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the Engineer-in-Charge shall be free to forfeit the entire amount of Earnest Money Deposit/Performance Guarantee. (Scanned copy to be uploaded at the time of submission of bid).

- 2.4 **When bids are invited from** Non CPWD/MES/PWD contractors, as per the provisions of clause 2.2, it will be mandatory for Non-CPWD contractors to upload the work experience certificate(s) and affidavit as per the provisions of clause 1.2.2. But for such bids, Class-I A and above registered contractors of composite category of CPWD/MES/PWD are eligible to submit the bids without submission of work experience certificate and affidavit. Therefore, CPWD/MES/PWD class-I A and above registered contractors of composite category of CPWD/MES/PWD shall upload

two separate letters for experience certificate and affidavit that these documents are not required to be submitted by them. Uploading of these two letters is mandatory otherwise system will not clear mandatory fields.

3. Agreement shall be drawn with the successful bidders on prescribed Form No. CPWD 7 amended up to **DG/CON/302 dated 09/02/2018** which is available as a Govt. of India Publication and also available on website [www.cpwd.gov.in](http://www.cpwd.gov.in). Bidder shall quote his rates as per various terms and conditions of the said form, which will form part of the agreement.
4. The time allowed for carrying out the work will be **12 (Twelve) Months** from the date of start as defined in schedule 'F' or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the bid documents.
5. **The site for the work is available.**  
~~The architectural and structural drawings shall be made by successful bidder and got approved and vetted from IIT/NIT/Sates govt. institutes. (If applicable)~~
6. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents except Standard General Conditions of Contract Form can be seen from website [www.tenderwizard.com/AIIMS BHOPAL](http://www.tenderwizard.com/AIIMS_BHOPAL), [www.aiimsbhopal.edu.in](http://www.aiimsbhopal.edu.in) or [www.eprocure.gov.in](http://www.eprocure.gov.in) free of cost.
7. After submission of the bid the contractor can re-submit revised bid any number of times but before last date and time of submission of bid as notified.
8. While submitting the revised bid, contractor can revise the quoted rates but before last date and time of submission of bid as notified.
9. When bids are invited in three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted then the bid submitted earlier shall become invalid.
10. Earnest Money in the form of Treasury Challan or Demand Draft or Pay Order or Banker`s Cheque or Deposit at Call Receipt or Fixed Deposit Receipt of a Scheduled Bank (drawn in favour of **Director, AIIMS Bhopal**) shall be scanned and uploaded to the e-Tendering website within the period of bid submission.

The original EMD should be deposited in the office of Executive Engineer, inviting bids within the period of bid submission.

A part of earnest money is acceptable in the form of Bank Guarantee also. In such case, minimum 50% of earnest money or Rs. 20 lakh, whichever is less, shall have to be deposited in shape prescribed above, and balance may be deposited in shape of Bank Guarantee of any Scheduled Bank having validity for **120 (One Hundred Twenty) days** or more from the last date of receipt of bids which is to be scanned and uploaded by the intending bidders.

Copy of Enlistment Order and certificate of work experience and other documents as specified in the press notice shall be scanned and uploaded to the e-Tendering website within the period of bid submission. 11. The contractors registered prior to 01.04.2015 on e-tendering portal of tender wizard shall have to deposit tender processing fee at existing rates or they have option to switch over to the new registration system without tender processing fee any time.
12. **The bid submitted shall become invalid and e-Tender processing fee shall not be refunded if:**
  - a) The bidder is found ineligible.
  - b) The bidder does not deposit original EMD Executive Engineer (E), AIIMS Bhopal.
  - c) The bidder does not upload all the documents (including GST registration) as stipulated in the bid document including the copy of receipt for deposition of original EMD.
  - d) If any discrepancy is noticed between the documents as uploaded at the time of submission of bid and hard copies as submitted physically by the lowest bidder in the office of bid opening authority.
  - e) If a tenderer quotes nil rates against each item in item rate tender or does not quote any percentage above / below on the total amount of the tender or any section /sub head in percentage rate tender, the tender shall be treated as invalid and will not be considered as lowest tenderer.
13. The contractor whose bid is accepted will be required to furnish performance guarantee of 5% (Five Percent) of the bid amount within the period specified in Schedule F. This guarantee shall be in the form of cash (in case guarantee amount is less than Rs. 10000/-) or Deposit at Call Receipt of any Scheduled Bank/Banker's Cheque of any Scheduled Bank/Demand Draft of any Scheduled Bank/Pay Order of any Scheduled Bank (in case guarantee amount is less than Rs. 1,00,000/-) or Government Securities or Fixed Deposit Receipts or Guarantee Bonds of any Scheduled Bank or the State Bank of India in accordance with the prescribed form. In case the contractor fails to deposit the said performance guarantee within the period as indicated in Schedule 'F' including the extended period if any, the Earnest Money deposited by the contractor shall be forfeited automatically without any notice to the contractor. The Earnest Money deposited along with bid shall be returned after receiving the aforesaid performance guarantee. **The contractor whose bid is accepted will also be required to furnish either copy of applicable licenses / registrations or proof of applying for obtaining labour licenses, registration with EPFO, ESIC and BOCW Welfare Board including Provident Fund Code No. if applicable and also ensure the compliance of aforesaid provisions by the sub-contractors, if any, engaged by the contractor for the said work and Programme Chart (Time and Progress) within the period specified in Schedule F.**

## 14. The description of the work is as follows:-

**“Annual operation and minor maintenance of Fire Alarm System and PA System at AIIMS Bhopal.”**

Intending Bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their bid. A bidder shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The bidder shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a bid by a bidder implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plant, etc. will be issued to him by the Government and local conditions and other factors having a bearing on the execution of the work.

15. The competent authority on behalf of the **Director, AIIMS Bhopal** does not bind itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without the assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.
16. Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable for rejection.
17. The competent authority on behalf of **Director, AIIMS Bhopal** reserves to himself the right of accepting the whole or any part of the bid and the bidder shall be bound to perform the same at the rate quoted.
18. The contractor shall not be permitted to bid for works in the AIIMS Bhopal responsible for award and execution of contracts, in which his near relative is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Junior Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any Gazetted Officer in the AIIMS Bhopal. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department.
19. No Engineer of Gazetted Rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is allowed to work as a contractor for a period of one year after his retirement from Government service, without the prior permission of the Government of India in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the bid or engagement in the contractor's service.

20. The bid for the works shall remain open for acceptance for a period of **Sixty (60 ) days** from the date of opening of **PQ bid** in case bids are invited on two envelop system(strike out as the case may be). If any bidder withdraws his bid before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the bid which are not acceptable to the department, **then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid. Further the bidder shall not be allowed to participate in the re-bidding process of the work.**
21. This Notice Inviting Bid shall form a part of the contract document. The successful bidder / contractor, on acceptance of his bid by the Accepting Authority shall within 15 days from the stipulated date of start of the work, sign the contract consisting of : -

AND WHEREAS to meet the purpose aforesaid both the parties have agreed to enter into this Integrity Agreement (hereinafter referred to as “Integrity Pact” or “Pact”), the terms and conditions of which shall also be read as integral part and parcel of the Tender/Bid documents and Contract between the parties.

NOW, THEREFORE, in consideration of mutual covenants contained in this Pact, the parties hereby agree as follows and this Pact witnesses as under:

**Article 1: Commitment of the Principal / Owner**

1. The Principal/Owner commits itself to take all measures necessary to prevent corruption and to observe the following principles:
  - a. No employee of the Principal/Owner, personally or through any of his/her family members, will in connection with the Tender, or the execution of the Contract, demand, take a promise for or accept, for self or third person, any material or immaterial benefit which the person is not legally entitled to.
  - b. The Principal/Owner will, during the Tender process, treat all Bidder(s) with equity and reason. **Article 2: Commitment of the Bidder (s) / Contractor (s)**

1. It is required that each Bidder / Contractor (including their respective officers, employees and agents) adhere to the highest ethical standards, and report to the Government / Department all suspected acts of **fraud or corruption or Coercion or Collusion** of which it has knowledge or becomes aware, during the tendering process and throughout the negotiation or award of a contract.
2. The Bidder(s) / Contractor(s) commit himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the Tender process and during the Contract execution:
  - a. The Bidder(s) / Contractor(s) will not, directly or through any other person or firm, offer, promise or give to any of the Principal / Owner's employees involved in the Tender process or execution of the Contract or to any third person any material or other benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the Tender process or during the execution of the Contract.

This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to cartelize in the bidding process.
  - c. The Bidder(s) / Contractor(s) will not commit any offence under the relevant IPC/PC Act. Further the Bidder(s) / Contractor(s) will not use improperly, (for the purpose of competition or personal gain), or pass on to others, any information or documents provided by the Principal/Owner as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.

- d. The Bidder(s)/ Contractor(s) of foreign origin shall disclose the names and addresses of agents / representatives in India, if any. Similarly Bidder(s)/Contractor(s) of Indian Nationality shall disclose names and addresses of foreign agents/representatives, if any. Either the Indian agent on behalf of the foreign principal or the foreign principal directly could bid in a tender but not both. Further, in cases where an agent participates in a tender on behalf of one manufacturer, he shall not be allowed to quote on behalf of another manufacturer along with the first manufacturer in a subsequent/parallel tender for the same item.
- e. The Bidder(s)/ Contractor(s) will, when presenting his bid, disclose (with each tender as per Performa enclosed) any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the Contract.
3. The Bidder(s) / Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.
4. The Bidder(s) / Contractor(s) will not, directly or through any other person or firm indulge in fraudulent practice **means a willful misrepresentation or omission of facts or submission of fake / forged documents in order to induce public official to act in reliance thereof, with the purpose of obtaining unjust advantage by or causing damage to justified interest of others and/or to influence the procurement process to the detriment of the Government interests.**
5. The Bidder(s) / Contractor(s) will not, directly or through any other person or firm use Coercive Practices (means the act of obtaining something, compelling an action or influencing a decision through intimidation, threat or the use of force directly or indirectly, where potential or actual injury may befall upon a person, his / her reputation or property to influence their participation in the tendering process).

### **Article 3: Consequences of Breach**

1. Without prejudice to any rights that may be available to the Principal/Owner under law or the Contract or its established policies and laid down procedures, the Principal / Owner shall have the following rights in case of breach of this Integrity Pact by the Bidder(s)/Contractor(s) and the Bidder / Contractor accepts and undertakes to respect and uphold the Principal / Owner's absolute right:
2. If the Bidder (s) / Contractor(s), either before award or during execution Contract has committed a transgression through a violation of Article 2 above or in any other form, such as to put his reliability or credibility in question, the Principal/Owner after giving 14 days notice to the contractor shall have powers to disqualify the Bidder(s)/ Contractor(s) from the Tender process or terminate / determine the Contract, if already executed or exclude the Bidder/Contractor from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of transgression and determined by the Principal/ Owner. **Such exclusion may be forever or for a limited period as decided by the Principal/Owner.**
3. **Forfeiture of EMD / Performance Guarantee / Security Deposit:**  
If the Principal/Owner has disqualified the Bidder(s) from the Tender process prior to the award of the Contract or terminated/determined the Contract or has accrued the right to terminate/determine the Contract according to Article 3(1), the Principal/Owner apart from exercising any legal rights that may have accrued to the Principal/Owner, may in its

considered opinion forfeit the entire amount of Earnest Money Deposit, Performance Guarantee and Security Deposit of the Bidder / Contractor.

4. **Criminal Liability:** If the Principal/Owner obtains knowledge of conduct of a Bidder or Contractor, or of an employee or a representative or an associate of a Bidder or Contractor which constitutes corruption within the meaning of Indian Penal code (IPC)/Prevention of Corruption Act, or if the Principal/Owner has substantive suspicion in this regard, the Principal/Owner will inform the same to law enforcing agencies for further investigation.

**Article 4: Previous Transgression**

1. The Bidder declares that no previous transgressions occurred in the last 5 years with any other Company in any country confirming to the anticorruption approach or with Central Government or State Government or any other Central/State Public Sector Enterprises in India that could justify his exclusion from the Tender process.

Necessary repairs for deficient or inoperable devices such as those found during the course of system testing, inspection or preventative maintenance, or have failed during operation will be provided. Only original replacement components manufactured by the original equipment manufacturer or other compatible components are used in order.

**Emergency Service**

Emergency service response between scheduled tests will be available 24 hours a day / 7 days a week to minimize system down time .Emergencies will be determined by Owner and Subcontractor. On-Site Response will be provided via a telephone response within 30 minutes and Service Technicians will be onsite within four (4) hours. Non-emergency calls, as determined by Owner and Subcontractor, will be handled the next business day.

**On Site Staffing**

Trained and certified personnel for on-site system support will be provided. As part of the services, any additional training will be provided while technicians are on site.

1. Checking of electrical terminals, contact points of the starters/contractors, and relays installed in various control panels.
2. The contractor shall not dismantle and remove any items without the knowledge of the Security officer and engineer. Dismantled items shall be the property of the AIIMS.
3. Contractor will visit the site as and when called by the Security Officer and engineer. On his visit he should meet the Security Officer& engineer and will report about satisfactory working of all equipment's.
4. The contractor will be responsible not only for his own men and material but also for the security of the equipment/ materials of the AIIMS. The cost of repair/replacement of equipment damage due to mishandling by the worker of the contractor will be deducted from the contractor's bill after loss assessment by the Fire Officer&Engineer. The assessment of the Fire Officer will be final and binding on the contractors
5. **Tools & Tackles:** The bidder should provide all tools and tackles required for the safe and satisfactory maintenance of the related equipment.

**MAINTENANCE SCHEDULE**

The following works/ checks are required to be performed on monthly / quarterly / half yearly basis and record all the activities in the log book with date and time which shall be counter signed by the Assistant Engineer (E)/ Competent authority of Project Cell, AIIMS Bhopal:

**1. Weekly inspection of FAS:-**

- a. Clean all the control panels, sounders and call boxes.
- b. While cleaning each panel, verify whether any fault indication lamp is on. If it is on with or without an alarm, investigate and intimate to the JE in-charge.
- c. Check whether all panel lamps are healthy by the “panel lamp test button” in each panel.
- d. Check that the system operates under mains failure condition, by switching of the mains supply to the C& I panel and testing any zone for fault/ fire condition from the zonal panel. Confirm also that the audiovisual alarm comes up in the C & I panel. Restore mains supply after the test.
- e. Lock all the panel instruments in C & I panel.
- f. If lead acid type battery is used for FAS system, check the electrolyte level (and top up with distilled water, as required) and specific gravity.
- g. Inspect the fuel tank of any sedimentation, clean up.
- h. Check shaft alignment and condition of anti-vibration mounting in case any abnormal noise or vibration is observed.
- i. Conduct magger test on all cabling mains and control wiring motors and earth test (Earth test is to be in summer and megger test using monsoon).

**2. Monthly Checks of FAS:-**

- a. Operation and readiness of system during mains failure.
- b. Checks battery water level & specific gravity of electrolyte.
- c. Checks the fire circuit of each zone from the panels.
- d. Checks whether signals of fire and fault get transmitted from zonal panel to main panel.
- e. Performance checks of the hooters shall be done along with the performance check of the manual call points.
- f. Check smoke detectors, if required cleaning shall be carried out with suitable reagents.
- g. Checking of main control panel of fire alarm system.

**3. Quarterly Checks of FAS:-**

- a. Check fault circuit of each zone by actually disconnecting wire by removing detectors.
- b. Check fire circuits by facilitating actual smoke to one detector of each zone.
- c. Cleaning of all types of detectors with suitable means.

**4. Half-yearly Checks of FAS:-**

- a. All the checks quarterly's shall be repeated.
