Corrigendum 2

Sealed tender is invited from experienced registered contractors/firms in various classes with the Deptt. Of CPWD/M.P. Government etc./ PSU for Civil Maintenance and Repair works on Delhi Schedule of Rates (DSR) 2013 for AIIMS Bhopal.

(A) Name of work:- Annual rate contract for the Civil Maintenance and Repair works

The condition given in the tender on page No.5 as

“Copies of EPF & ESI Registration details if applicable.”-----**Deleted.**

The condition mentioned in the Annexure -VI under the heading Detail Special Conditions of the tender For Providing Services for the maintenance and repairs of CIVIL works:-

6. Evidence and Terms of Insurance

(B)“The Contractor shall take out appropriate insurance to cover workers, staff and particularly labours.” -----**Deleted.**

(C) Para 21 on page 7 of tender document under the heading “General Terms and conditions” is deleted & in Contract agreement format Enclosure III condition 5 on page 24 is also deleted. The modified Para 21 of page 7 & condition 5 of page 24 may now be read as:-

Payment shall be released in running bills after the successful completion of the items of work and receipt of bill after deducting TDS as per Income tax Rules and any other deductions as per Government rules. Part payment can be released against part of work quantity of the Items at the request of the contractor duly recommended by Engineer-in- Charge and it will be adjusted on completion of 100% work completion of the said work duly accepted by the contractor while making final payment bill of the contractor. EMD Rs. 20000/- deposited by the contractor shall be treated as Performance Guarantee and shall remain with AIIMS Bhopal for 15 months period. Performance Guarantee shall initially be valid up to the stipulated date of completion of the work plus the main defect liability period 3 months & shall be further extended depending on the Authority **Director AIIMS Bhopal** and will be released without interest after full satisfaction of Director AIIMS Bhopal

From each running bill the deduction of 10% shall be made on account of security deposit. 100% payment will be released if the contractor submits a guarantee @ 10% of the value of work order in the form of Deposit at Call receipt of any scheduled bank/Banker's cheque/Demand Draft /Pay order of any Scheduled Bank or Government Securities or Fixed Deposit Receipts or Guarantee Bonds of any Scheduled Bank in accordance with the prescribed form valid for 3 months & shall be further extended depending on the Authority **Director AIIMS Bhopal** and will be released without interest after full satisfaction of Director AIIMS Bhopal.

The agreement shall be executed and the work order shall be issued as per the requirement of works in pieces & time to time, the contractor shall have no right to claim for the entire quantity of works to be executed at any time during the currency of the contract. The work orders will be issued in different pieces and contractor has to execute the works as per specifications.

Payment shall be made through Account Payee Cheque or Electronic Clearing System only and the charges shall be deducted from the bill by DDO AIIMS Bhopal.

Cost of tender form is Non – refundable Rs.525/- . Technical bid of tender shall be deposited up to 12.30 hrs. & shall be opened at 13.00 hrs. on the same day. Tender document can be seen and down loaded from www.aiimsbhopal.edu.in or may be obtained directly from AIIMS Bhopal. Bidders are advised to visit the web site regularly as the corrigendum will be up loaded on website only.
