Part payment can be released against completion of part quantity of the Items of supply in form of running bill. However on the completion of supply, the entire items shall have to be completed within the stipulated period. 100% PAYMENT WILL BE MADE AFTER completion of supply, after adjustment of supply and amount paid in part payment made, if any full satisfaction of the Engineer In-charge. Payment shall be made through Account Payee Cheque or Electronic Clearing System only and the charges shall be deducted from the bill.
4. Payment shall be made through Account Payee Cheque or Electronic Clearing System only and the charges shall be deducted from the bill.
5. Tenderers may please note that they shall follow the safety and security procedures while at work in AIIMS as per the Institute's norms
6. Tenderers may please note that the work should be executed as per the standard specification and the measurements shall be recorded CPWD accordingly.
7. The work shall be carried out as per standard specifications of CPWD relevant IS code if the CPWD specification are silent and also as per manufacturers specifications as directed by Engineer-In-Charge.
8. If the contractor fails to maintain the required progress or to complete the work and clear the site on or before the expiry of contract period he shall on account of such breach, pay agreed compensation at ½% of the value of the work per week subject to maximum of 10% of tendered value of work.
9. AIIMS does not bind itself to accept the lowest or any other quotation, and reserves the authority to reject any or all of the quotations or to allot part of the works to different agencies without assigning any reason thereof. All quotations, in which any of the prescribed conditions is not fulfilled or the agencies put any condition not acceptable to AIIMS, Bhopal including that of conditional rebate is liable to be summarily rejected.
10. The quotation must be quoted duly typed on the letter heads of the supplier / manufacturer duly mentioned full address, VAT No. / PAN No. / TDS No. / TIN No. and must be in a sealed cover which should be superscribed Quotation for "Name of work".
