1. Sealed tenders are invited under Two bid system (Part-I Earnest Money and Technical bid & Part-II (Financial bid) from prominent firms, whole-sellers, vendors, sellers or reputed dealers for a period of 12 months from the date of opening the bid..
2. The cost of Tender Document is Rs.525/-(Five Hundred Twenty Five only) (Non Refundable).Tender document can be had in person from the undersigned on any working day from 10:00 to 15.00 Hr on payment of said cost in the form of Demand Draft in favour of “Director, AIIMS Bhopal”, payable at Bhopal. The Tender Document can also be downloaded from the AIIMS website <http://www.aiimsbhopal.edu.in> / <http://www.aiimsbhopal.nic.in>) In this case it is necessary for the Tenderer to pay the cost Rs 525/- in the form of Demand Draft drawn in favour of “Director, AIIMS Bhopal”, payable at Bhopal and is kept in the Technical Bid Envelope. The reference of the DD is to be super scribed on the main envelope of Technical Bid “Down Loaded Tender from Website”.
3. The amount of Earnest money deposit as mentioned **in the tender is required to Deposit with Technical Bid as given in Schedule of Tender,** which is Non-Interest bearing. The Bidder is required to deposit earnest money along with Technical Bid document in Technical Bid Envelope in the form of Demand Draft/Banker’s Cheque/FDR from any Nationalized/Scheduled Bank and the same should be drawn in favour of “**Director, AIIMS Bhopal**” payable at Bhopal. No tender will be accepted without EMD as required.
4. The Tenderer is required to submit two sealed envelope super scribed as (i) **Envelope – I - Technical Bid**, and (ii)**Envelope- II –Financial Bid**. Both envelopes should be kept **in one main sealed envelope** super scribed as “Tender for supply of Gardening equipments due on **27.11.2014**”.
5. The tenderer has to drop by hand the sealed cover in above manner in the Tender Box kept in the office of the Superintending Engineer AIIMS Bhopal Hospital Building, AIIMS Bhopal, Saket Nagar-462024 (MP) on or before 27.11.2014 by 12.30 Hrs. positively. The tender shall not be accepted beyond the stipulated date and time under any circumstances whatsoever.
6. The Technical bid will be opened on the same day at 13.00 hrs by a Committee constituted by the competent authority of AIIMS Bhopal, in the presence of the Tenderers or their authorised representative who wish to be present. **The date and**

time for opening of financial bids of the technically qualified tenderers shall be communicated later as per convenience.

7. The Authority reserves the right to reject/cancel any or all the tenders at any time or to relax/amend/withdraw any of the terms and conditions as contained in the Tender Documents without assigning any reason, thereof. Any inquiry after submission of the tender will not be entertained.
8. EMD shall be refunded to the unsuccessful bidders within 30 days of award of contract to the successful bidder/bidders.
9. AIIMS Bhopal reserves the full rights to increase/decrease the quantity of items in the tender as per requirement.
10. Any dispute is subject to the jurisdiction of Civil Court Bhopal.

Chapter – I

GENERAL INSTRUCTIONS TO BIDDERS

1. The Tenderer must fulfil the following specifications/conditions:-
 - (a) A Registered Office or Branch Office preferably located in Madhya Pradesh. Availability of a responsible person on call working days between 09.00 Hrs to 17.30 Hrs.
 - (b) The tenderer should have its own Bank Account, PAN, TAN, TIN, VAT and Service Tax Number .Payment will be made electronically only.
 - (c) The tenderer should be a reputed supplier having at least three years dealing experience with the Government Departments Certificate in token of Proof of experience, of the concerned Department should be enclosed for ready reference.
 - (d) The Tenderer should submit a certificate, along with its Technical bid, indicating that their representative will have to accompany show room of samples of Gardening Items for Inspection by gardening committee of AIIMS Bhopal, when they (Tenderer) get the Official Intimation from AIIMS Bhopal that their firm found “Technical Responsive” and the rates for each Gardening equipments have been quoted in the Financial bid (Chapter 7) accordingly are the lowest rates. The Tenderer should also enclose a duly stamped signed copy of the Terms & Conditions of the tender documents with Technical bid conveying acceptance thereof.
 - (e) The rates are to be quoted on FOR-Destination basis only. However, their breakup is necessary.
 - (f) The tenderer should submit copies of the Income Tax Returns for the last three financial years (i.e. for 2011-12, 2012-2013 and 2013-2014), Copies of Audited Balance Sheets and a letter from Agency /Company/owner/ of the firm indicating Financial Turnover must enclosed with Technical Bid Documents.
 - (g) The tenderer should furnish copies of average financial turnover of Rs 3.00 lakhs for the last three financial years enclosing these with copies with previous purchase order of similar nature of items with showing values of
 1. Copy of single purchase or supply order showing value of Rs 4.60 lakhs.OR
 2. Copy of two purchase or supply order showing value of Rs 3.50 lakhs.OR
 3. Copy of three purchase or supply order showing value of Rs 2.30 lakhs.

This is required to be submitted for the prequalification eligibility.

Separate Sheet may used for the details.

(i) The tenderer shall furnish a self attested certificate that the firm has not been blacklisted in the past by any government/Private institution. The tenderer/supplier has to give a written statement that there is no vigilance/CBI/FEMA case pending against the firm/supplier and the firm has not been blacklisted in the past by any Govt. or Private Organization disclosing of information if found wrong the EMD of contract shall be forfeited.

(ii) Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable for rejection

(h) The tenderer should submit the performance Guarantee for 5% of the value of the work order in favour of "Director AIIMS Bhopal" for a period of 12 months with claim period of 3 months from the date of agreement of the contract work. This guarantee shall be in the form of Fixed Deposit /Bank Guarantee of any scheduled bank/Banker's cheque/Demand Draft /Pay order of any Scheduled Bank or Government Securities or Fixed Deposit Receipts or Guarantee Bonds of any Scheduled Bank in accordance with the prescribed form valid for 12 months with a claim period of 3 months from the date of issue of same by the Bank.

Chapter -2

TERMS AND CONDITIONS

1. Rates quoted should be valid for 12 months from the date of opening of Technical Bid. It will be under discretion of the tenderer to increase duration of validity of rates after this period after receiving request from AIIMS Bhopal. The Rates quoted will remain the same for the extended period..

2. ELIGIBILITY/EVALUATION CRITERIA

3. The tenderer must fulfil the following specifications (all documentary proofs, self-attested and stamped (seal), are required to be submitted along with the technical bid):

(a) Documentary proof of the Registered Office of the Tenderer. The registered office preferably should be located in the in Bhopal/Indore Madhya Pradesh. Local distributor in Bhopal/Indore who has spare parts and service centre.

(b) Give details of your after sale service.

(c) Give detailed price list of your common parts for the equipments mentioned for supply that are frequently required.

(d) **Technical Responsive” bidders** will arrange visit of our Gardening committee members to a local Bhopal /Indore show room of your models/equipments.

(e) The tenderer should have its own Bank Account, PAN, TIN, TAN Number, VAT and Service Tax Number. Self-attested Photostat of all should be enclosed.

(f) The Tenderer should be a reputed & financially sound supplier having minimum experience of three years and expertise in supplies to Central Government/Institutes/Ministries/Departments/PublicSectorUndertakings/Autonomous Institutes/Reputed Corporate Organization etc. Proof of experience in the form of copy of certificates obtained from Govt. Deptt./PSU's,/Autonomous Institutes/Reputed Corporate Organization etc. should be enclosed if available. Copy of Income Tax Return for the last three years may also be enclosed with the Technical Bid.

(g) The Tenderer should have an annual turnover of Rs. 3 Lakh during last three years. The balance sheet duly signed and stamped by the Chartered Accountant/Company Secretary/owner indicating last three financial years Turnover, Profit and Loss figures (i.e. FY 2011-2012, 2012-2013 and 2013-2014) along with copies of relevant stipulated proof may also be enclosed with Technical bid.

(h) The tenderer should furnish copies of average financial turnover of Rs 3.00 lakhs for the last three financial years enclosing here with copies with previous purchase order of similar nature of items with showing values of

1. Copy of single purchase or supply order showing value of Rs 4.60 lakhs.

OR

2. Copy of two purchase or supply order showing value of Rs 3.50 lakhs.

- 3 Copy of three purchase or supply order showing value of Rs 2.30 lakhs.

This is required to be submitted for the prequalification eligibility.

- (i) The Tenderer should submit a certificate, along with its Technical bid, indicating that their representative will have to accompany show room of samples of Gardening Items for Inspection by gardening committee of AIIMS Bhopal, when they (Tenderer) get the Official Intimation from AIIMS Bhopal that their firm found “Technical Responsive” and the rates for each Gardening equipments have been quoted in the Financial bid (Chapter 7) accordingly are the lowest rates (inspection before issue of work order). The Tenderer should also enclose a duly stamped signed copy of the Terms & Conditions of the tender documents with Technical bid conveying acceptance thereof.
- (j) The tendering Firm/Agency/Company are advised in their own interest to quote their rates for all the items as per the specifications laid down in Financial Bid (Chapter-7).
- (k) Financial Bid shall only be opened and bid shall be decided on the basis of each Item wise lowest rate quoted by bidders for items only for those qualified technically bidders, shall be given opportunity by the competent authority of AIIMS Bhopal for supply at the lowest rates.
- (l) Technical Bid should accompany with EMD amount as required in tender document & it should be in the form of Single Demand Draft/Banker’s Cheque/FDR drawn from any Nationalized/Scheduled Bank in favour of “**Director, AIIMS Bhopal**”, **Payable at Bhopal**, failing which the tender shall be declared un-responsive. EMD shall be refunded to the unsuccessful bidders within 30 days of award of contract to the successful bidder/bidders. Please note no interest will be paid by AIIMS Bhopal in lieu of Earnest Money Deposit to any Bidder/ Agency.

PAYMENT TERMS: - Payment shall be released after the successful delivery of the items and receipt of bill after deducting TDS as per Income tax Rules and any other deductions as per Government rules. Part payment can be released against supply of part quantity of the Items at the request of the supplier duly recommended by Engineer-in- Charge and it will be adjusted on completion of 100% supply of the material duly accepted by the supplier while making final payment bill of the contractor; however the delivery of the entire items shall have to be completed within the stipulated period.

- (m)The tenderer shall furnish a self attested certificate on stating that the firm has not been blacklisted in the past by any government/Private institution. The tenderer/supplier has to give an undertaking as given at Annexure-IV that there is

no vigilance/CBI/FEMA case pending against the firm/supplier and the firm has not been blacklisted in the past by any Govt. or Private Organization.

- (n) Details regarding quality, specification etc. has been given against each item in the Financial Bid (Chapter-7). Rates should strictly be quoted accordingly. Items where brand has not been indicated, rates should be quoted for best available/good quality/brand product conforming to the prescribed/prevaling standards.
- (o) In his own interest the tenderer is advised to submit the desired papers/documents with their technical bid as per the specifications indicated in **Chapter-5 (Check list)** failing which their bids shall be declared un-responsive.

OTHER ESSENTIAL TERMS & CONDITIONS:-

4. The selected tenderer would be required to arrange supply as per the Despatch Instructions/Purchase cum Supply Order during the working hours of the Institute within 15 days after receipt of the order. Since the rates are to be quoted on destination basis, no other charges whatsoever are payable extra.
5. The selected tendering Firm/Agency/Company shall also provide the name and mobile number of a key person, who can be contacted at any time, even beyond the office hours and on holidays. The person should be capable of taking orders and making arrangement for supply of the desired items even on short notice to AIIMS Bhopal.
6. Order shall be issued on requirement basis. Bills in triplicate for the items supplied by the selected firm(s) should be raised for payment. Payment shall be released after deducting TDS as per Income Tax Rules and any other deductions as per Government rules and payment shall be released only after it is ensured that the items/quantity and quality of items supplied are to the entire satisfaction of this office. If any items are found to be defective, or not of the desired quality etc., the same shall be replaced immediately, for which no extra payment shall be made by AIIMS Bhopal.
7. If the selected firm fails to deliver the items or replace the defected/spurious items within the stipulated date & time, a penalty on a daily basis for delay @ Rs. 500/- (Five Hundred) on per day basis, subject to maximum of Rs. 1000/- per item as penalty and the actual cost paid to be an outside agency by the All India Institute of Medical Sciences (AIIMS) Bhopal, for the desired Gardening equipments, shall be deducted from the firm's pending bills.
8. All India Institute of Medical Sciences (AIIMS) Bhopal shall be the sole authority to cancel or amend the order, as per requirement, and also to place order for supply of items beyond office hours/holidays/place of supply for which, no additional payment shall be made.
9. The bills raised by the selected tendering Firm/Agency/Company should have all tax registration numbers printed on bill. The bill shall be signed by the authorized signatory of the firm across a revenue stamp. Validity of the tax registration during the currency of contract shall be the sole responsibility of the tendering Firm/Agency/Company. The bill shall be raised indicating permissible taxes separately and the copies of proof of Service

Tax/VAT or other applicable taxes deposited to Tax Authorities by the firm for recent period, just before the submission of Bills must also be enclosed for reference of AIIMS Bhopal authorities.

10. The tendering Firm/Agency/Company shall be bound by the details furnished by him to the All India Institute of Medical Sciences (AIIMS) Bhopal while submitting the tender or at subsequent stage. Upon selection of the tendering Firm/Agency/Company, if at any stage, the documents furnished by him/her is found to be false or the quality of the articles are found of poor quality/ different specifications, it would be deemed to be a breach of terms of contract, the contract shall be cancelled and performance security shall be stand forfeited.
11. The rate quoted by the selected tendering Firm/Agency/ Company, and as approved by the All India Institute of Medical Sciences (AIIMS) Bhopal, shall remain valid throughout the period of contract and the request to increase the rates for any or all items, during the currency of contract, shall not be entertained at any stage.
12. The selected firm(s) shall not be allowed to transfer, assign, pledge or sub-contract its rights and liabilities under this contract to any other agency (ies) without prior written consent of the All India Institute of Medical Sciences (AIIMS) Bhopal. If its found that the firm has given sub-contract for supply of Gardening equipments Items on the basis of procurement/ supply order, the contract shall stand cancelled & the performance security shall stand forfeited.
13. The conditional/incomplete bids shall not be considered and shall be declared un-responsive.
14. All entries in the tender form should be legible and filled clearly in the published Financial Bid Form (Chapter-7) only. If the space furnishing the information is found insufficient, a separate sheet duly signed by the authorized signatory may be attached. No overwriting or cutting or other than issued forms is permitted in the bid forms. In such cases, the tender shall be declared un-responsive.
15. The tender documents should be sealed and clearly super-scribed with the words “Tender for Supply Gardening equipments to AIIMS Bhopal”.
16. If a tendering Firm/Agency/Company decides to withdraw from the bidding before the financial bids are opened, the AIIMS Bhopal shall have the authority to forfeit the EMD deposited by the Tenderer with the technical bid.
17. All India Institute of Medical Sciences (AIIMS) Bhopal shall not be responsible for any financial loss or other damage or injury to any item or person deployed/supplied by the successful bidder in the course of their performing the duties to this office in connection with purchase order/supply order for Gardening equipments.
18. The Competent Authority of All India Institute of Medical Sciences (AIIMS) Bhopal reserves the right to relax/withdraw any of the terms and conditions mentioned in the tender documents, if doing so is in the interest of the AIIMS Bhopal.

19. The Tender should be dropped only in the designated Tender Box kept in the Office of the Superintending Engineer AIIMS Bhopal Hospital Building, AIIMS Bhopal, Saket Nagar Bhopal-462024 (MP).
