1	Temendra Katre	Senior Accounts Officer	Individual is working in a state PSU. Also, he has submitted application without NOC, vigilance clearance certificate from current employer, and experience certificate as per advertisement criteria.
2	Lalita Garg	Senior Accounts Officer	As per DoPT order no 6/8/2009-Estt(PayII) dated 17/06/2010, point 8.4, a mandatory 'cooling off' period of 3 years is essential for the individual since getting relieved from AIIMS Bhopal.
3	Muhammad Nawaz	Senior Accounts Officer	Individual is working in PSU which is not included in the eligibility criteria of the advertisement. Pay level is different (E1, E-2, E-3). NOC and vigilance clearance certificates have not been attached.
4	Banwari Lal Dhakar	Senior Accounts Officer	The hard copy of the application has been received after the last date. Hence, individual is not eligible for the current advertisement cycle.
