- 8. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.

The candidate should bring along original certificates in support of his/her age, educational/professional qualification, experience etc., two recent passport size colour photographs and a one set of self-attested photocopies of the relevant documents failing which he/she will not be allowed to participate in the interview or written test.
- 10. No travelling or other allowances will be paid to the candidate for appearing in written examination or for joining the post.
