1. To strengthen the infrastructure and capacity for handling infectious diseases in the country in terms of early and timely diagnosis, continuous monitoring and surveillance of existing as well as new pathogenic organisms, the Government of India has approved “Strengthening and up gradation of existing VRDLs for infectious disease diagnosis and research” under PM-ABHIM Scheme.

Regional Virology Laboratory is upgraded to IRDL which will be a comprehensive unit dealing with infectious diseases is sanctioned to AIIMS Bhopal which is a premier Institute of National Importance (INI) established by the Ministry of Health & Family Welfare, Government of India under the Pradhan Mantri Swasthya Suraksha Yojna (PMSSY) with the aim of correcting regional imbalances in quality tertiary level healthcare in the country and attaining self-sufficiency in graduate and postgraduate medical education and training.

6. **Age Concession:** Age relaxation is admissible in respect of Retrenched Government Employees, Departmental Candidates (including projects), and ex-servicemen in accordance with the instructions issued by the Central Government from time to time. Age concession to the extent of services rendered in the research projects will also be admissible for experienced and skilled persons. **The effective date for fulfilling eligibility criteria (including qualification and experience etc), upper age limit will be the date of Walk-In-Interview / Walk-In Written Test.**
7. **Date and Time of reporting:** 28<sup>th</sup> January 2025. The Candidates shall report at 10:00 am to the Principal Investigator at selection venue.
8. **Modality of selection:** Walk-in Interview / Walk-In Written Test, as mentioned above against various posts.
9. The candidates shall report for appearing in the walk-in-interview / Walk-In Written Test with
  - a. Duly filled application form
  - b. Self-attested photocopies of proof of date of birth (class 10<sup>th</sup> certificate/ school leaving certificate), eligibility qualification mark-sheets, degrees, experience certificate, caste certificate (if applicable), qualifying degree registration with statutory council (if applicable) and other relevant testimonials.

## TERMS & CONDITIONS

1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. Any misinformation detected at any stage will make the candidate liable for legal action. Permission to appear in the selection process does not approve the eligibility of the candidate. Even after qualifying the selection process the candidate may be rendered disqualified at the time of document verification if he/ she does not fulfil essential eligibility criteria.
2. These appointments will be made from the staff strength IRDL and appointment to IRDL will not vest any right to candidate for appointment within the sanctioned staff strength of AIIMS Bhopal.
3. **Tenure:** The assignments for contractual posts are purely on contract basis for the period specified above. The posts will be governed as per the rules / instructions received from the ICMR / DHR / competent authority from time to time. This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in AIIMS Bhopal or ICMR/DHR or for continued contractual appointment.
4. **Expiry of Contract:** The contract will automatically expire on completion of period specified above until it is renewed with mutual consent for the decided period. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
5. Continuation of this post is subject to the vacancies not being filled by the central recruitment examination conducted by ICMR.
6. **Leave:** The leave entitlement of the appointee shall be governed in terms of the ICMR leave policy governing extramural research projects as amended from time to time.
7. **Accommodation:** No hostel or any other accommodation will be provided by the Institute / Principal Investigator.
8. The candidate who is already in government service shall submit '**No Objection Certificate**' from the present employer at the time of walk-in-interview.
9. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
10. The candidate should bring along original certificates in support of his/her age, educational/ professional qualification, experience etc., two recent passport size colour photographs and a one set of self-attested photocopies of the relevant documents failing which he/she will not be allowed to participate in the walk-in-interview.
11. The candidate applying in response to his advertisement should satisfy themselves regarding their eligibility in all respects.
12. No travelling or other allowances will be paid to the candidate for appearing in walk-in-interview or for joining the post.
