**Eligibility Criteria:**

**Qualification:**

- For Junior Research Fellow (JRF):** BNYS (Bachelor of Naturopathy and Yogic Sciences), OR M.Sc in Yoga and Naturopathy OR M.Sc in Life Sciences/Equivalent with minimum of 60% marks. Candidate from background of Yoga with working experiences in this field will be given preference.
- For Physiotherapist:** Candidate should have master's degree (MPT) in Neurology/Neurosciences, recognized by state/national council or equivalent. Working experience in a hospital (> 50 bedded) will be given preference.

**Age Limit:** Age will be calculated till the date of interview. Relaxation in the age will be given to respective category as per rule of Govt of India/AIIMS/DST.

- For Junior Research Fellow (JRF):** Age should not be more than 30 years.
- For Physiotherapist:** Age should not be more than 30 years.

2. Covering letter and detailed Curriculum Vitae (CV) along with passport size photographs (2).
3. Original and attested photocopies of all documents, certificates, degrees and mark sheets (Xth class onwards).
4. Copies of certificates/testimonials/documents which the candidate may wish to bring to the knowledge of the selection committee.

## TERMS & CONDITIONS

1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. Any misinformation detected at any stage will make the candidate liable for legal action. Permission to appear in the selection process does not approve the eligibility of the candidate. Even after qualifying the selection process the candidate may be rendered disqualified at the time of document verification if he/ she does not fulfil essential eligibility criteria.
2. **Tenure:** The assignment will be governed as per the rules / instructions received from the STYAM (DST) / competent authority from time to time. This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in AIIMS Bhopal or STYAM (DST) or for continued contractual appointment.
3. **Expiry of Contract:** The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
4. **Leave:** The leave entitlement of the appointee shall be governed in terms of the SATYAM (DST) leave policy governing extramural research projects as amended from time to time.
5. **Accommodation:** No hostel or any other accommodation will be provided by the Institute / Principal Investigator.
6. The candidate who is already in government service shall submit 'No Objection Certificate' from the present employer at the time of walk-in-Interview
7. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
8. The candidate should bring along original certificates in support of his/her age, educational/professional qualification, experience etc., two recent passport size colour photographs and a one set of self-attested photocopies of the relevant documents failing which he/she will not be allowed to participate in the walk-in-written test.
9. The candidate applying in response to his advertisement should satisfy themselves regarding their eligibility in all respects.
10. No travelling or other allowances will be paid to the candidate for appearing in written examination or for joining the post.
11. Canvassing of any kind will lead to disqualification.
12. Private practice of any type is prohibited.
13. He / She can be posted at any place as per the requirement of the project including rural areas / field sites.
14. He / She is expected to conform to the rules of conduct and discipline as applicable to the institute employees.
15. The decision of the competent authority regarding the selection of the candidate will be final and no representation will be entertained in this regard.
16. The candidate should not have been convicted by any Court of Law.
