**Date and Time of Interview:**

Depending upon number of applications received candidates will be shortlisted for written test/skill test Date, Time and Venue of test would be intimated to concerned candidates. When called, the candidates shall report for appearing in the interview with

1. Duly Filled Application Form
2. Covering letter and detailed Curriculum Vitae (CV) along with passport size photographs (1)
3. Original and attested photocopies of all documents, certificates, degrees and mark sheets (Xth class onwards).

4. Copies of certificates/testimonials/documents which the candidate may wish to bring to the knowledge of the selection committee.

## **TERMS & CONDITIONS**

1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. The candidate should bring along original certificates in support of his/her age, educational/ professional qualification, experience etc., two recent passport size colour photographs and a one set of self-attested photocopies of the relevant documents failing which he/she will not be allowed to participate in the walk-in-written test.
9. The candidate applying in response to his advertisement should satisfy themselves regarding their eligibility in all respects.
10. No travelling or other allowances will be paid to the candidate for appearing in written examination or for joining the post.
