TERMS & CONDITIONS

1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. Any misinformation detected at any stage will make the candidate liable for disqualification & legal action. Permission to appear in the selection process does not approve the eligibility of the candidate. Even after qualifying the selection process the candidate may be rendered disqualified at the time of document verification if he/she doesn't fulfil essential eligibility criteria.
2. Tenure: The assignments are purely on contractual basis for the period specified above. This appointment will not vest any right to claim by the candidate for regular appointment or permanent

absorption in AIIMS Bhopal or for continued contractual appointment. The performance of the selected candidates will be reviewed every 3 months. Any unauthorised absence from duties for 3 or more working days shall lead to termination of contract.

3. Expiry of Contract: The contract will automatically expire after one year from date of selection and shall be **extended based on performance and availability of funds for Manpower**. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
4. Leave: The leave entitlement of the appointee shall be governed in terms of the Institute leave policy governing ad-hoc/extramural/short term research projects as amended from time to time.
5. Accommodation: No hostel or any other accommodation will be provided by the Institute/Nodal Officer of Project.
6. The candidate who is already in government service shall submit "No Objection Certificate" from the present employer at the time of walk-in-interview or written test.
7. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
8. The candidate should bring along original certificates in support of his/her age, educational/professional qualification, experience etc., two recent passport size colour photographs. One set of self-attested photocopies of the relevant documents would need to be submitted with the application form. Failing these, he/she will not be allowed to participate in the walk-in-interview.
