**OFFICE MEMORANDUM**

**Sub.: Holding of Press Conferences/talking to media by the Faculty/Officers/ employees of AIIMS, Bhopal**

It has been observed by competent authority that the Institute employees are unauthorizedly communicating with the Press/ Media/ Social Media either in their own name or under pseudonymous names or in the name of the AIIMS Bhopal by giving information/ statements about the activities/ affairs of the Institute without seeking permission from the competent authority despite various instructions having been issued from time to time in this regard from Government of India. But it is observed that the instructions are not being followed in letter and spirit.

2. In this regard, the undersigned is directed to invite attention of all concerned to the provisions contained in the CCS (Conduct) Rules, 1964 specially in Rule 11, which provided as under:

*"No Government servant shall, except in accordance with any general or special order of the Government or in the performance in good faith of the duties assigned to him, communicate, directly or indirectly, any official document or any part thereof or information to any Government servant or any other person to whom he is not authorized to communicate such document or information."*

3. In the light of above and various provisions contained in CCS (Conduct) Rules, 1964, specially in the Rule 11 of the CCS (Conduct) Rules, 1964 as above, are once again brought to the notice of all concerned and it is once again reiterated that violation of the provisions of Conduct Rules and other corresponding provisions amounts to a serious misconduct. All members of the Faculty/Residents Doctors/Officers/Staff/Employees are hereby advised to restrain from making statement/giving news or communicating with the Print/Electronic media or holding Press Conference or becoming part of it without obtaining approval from the Competent Authority.
