Overview

The Flo Trac sensor is a sterile, single use kit that monitors pressures when attached to pressure monitoring catheters. The disposable sterile cable with a red connector interfaces exclusively with an Edwards cable that is specifically wired for the pressure monitor being used. The disposable sterile cable with a green connector interfaces exclusively with the Edwards APCO cables for use with the Edwards arterial pressure based cardiac output monitoring devices or hardware.

The FloTrac sensor has a straight, flow-through design across the pressure sensors with an integral flush device.

The above patent deals with technologies & algorithms exclusive to Edwards for the purpose of calculation Stroke Volume of left ventricle. These above patents deals with technological breakthrough & unique algorithm developed by Edwards for the calculation of SV, SVV from standard deviation (Sd) of Intra-arterial blood pressure waveform.

The algorithm uses a method of calculating arterial compliance factor using age, gender & body surface area. Compliance factor thus calculated is used in the equation to compensate for its effects on Pulse pressure (PP).

The algorithm periodically calculates a "khi" factor by closely analyzing changes in Intra-arterial blood pressure waveform due to vascular tone changes. "Khi" factor is a function of change in MAP, upslope & downslope of the pressure waveform. This "Khi" factor is periodically calculated & applied to the SV equation to adjust for the effect of change in vascular tone on calculated SV.
