## **General Terms & Conditions**

1. **Procedure for submission of Bids if the Supplier Agency, want to participate in this Limited Tender Enquiry on behalf of Multiple Principal Companies:** The proposal from the eligible empanelled Supplier Agencies of Tender No. 103 under respective Category is invited under Two Bid System. If the participating Supplier Agency is authorized Distributor of Multiple Principal Companies, those are empaneled with AIIMS Bhopal for respective Category of Items mentioned in the Schedule of requirement as above, are requested to be submit their proposals on individual Principle Company Wise, clearly mentioned the Name of their Principal Company along with their name in the Technical Bid Envelope, Financial Bid Envelope and Outer Covers and in the Documents submitted in the respective Bid Envelope.
2. **Rejection of proposal of Non-Empaneled Principal Companies quoted by the Supplier Agency:** The participating Supplier Agency must ensure that they may have participated in this Limited Tender Enquiry for their Principle Empaneled companies products only. If any Supplier Agency found to be quoted for Non-empaneled Principle Companies, their proposal shall be rejected.
3. **Previous Purchase Orders copies:-**The participating bidders companies must enclose at least three numbers of previous purchase orders copies for requested items supplied to any Govt. Hospital/PSU/Corporate Hospitals in the Technical Bid Envelope.
4. **Performance Security Deposit (One time on Fixed Rate basis):-** The L-1 Supplier Agency is liable to be deposit Rs. 5000/- (Five Thousand only) as Performance Security deposit for the period of 15 months (One time) within 15 Days period on receipt of Notification of Award issued by AIIMS Bhopal in favor of "Director, AIIMS Bhopal" by the way of FDR/Bank Guarantee/Demand Draft.
5. **Specification/Quality of the Item to be supplied:** The ordered item store should be supplied strictly in accordance with the supply order and with the approved specification/samples (if any).
6. **Rate Validity Period:** The L-1 Rate offered by the any Supplier Agency, its Rates for supply of requested item shall be applicable for entire one year period from the date mentioned in the Contract Agreement and would be extendable by one year through mutual consent. 7. **Fall Clause:** If at any time during the execution of this Rate Contract, the Contractor/Manufacture/Distributor/Dealer reduces the sale price or sells or offers to sell such stores, as are covered under the contract, to any person/organization including the purchaser or any department of Central Government or any department of AIIMS Bhopal Hospital/PSUs at a price lower than the price chargeable under the contract during the Current Financial Year, he shall forthwith notify Medical Superintendent, The necessary difference amount about such reduction or sale or offer of sale to the purchaser and the price payable under the contract for the stores supplied after the date of coming into force of such reduction or sale or offer of sale shall stand correspondingly reduced and deposited to AIIMS Bhopal by the Bidder or AIIMS Bhopal will deduct from the pending bills/Performance Security Deposit to recover the loss to the Government.
8. **Supply/Delivery period:-**The delivery against supply order shall be completed within 30 days for Indian make items and within 45 days for imported items on receipt of the supply order from AIIMS Bhopal through email/Speed post.

9. **Penalty:-** If the L-1 Supplier Agency failed to supply the consumables as per the specifications mentioned in the order within the due dates mentioned in the Purchase Order of AIIMS Bhopal, the supplier is liable to pay LD of 1% of the order value for every month of delay beyond the due date, subject to a maximum of 5%. The Director, AIIMS Bhopal reserve the right to cancel the orders in case the delay is more than 45 days, and penalty, if any will be deducted from the SD (Security Deposit) or amount due to the suppliers.
