1. Parties :

The parties to the contract are the contractor (the tenderer to whom the work have been awarded) and the AIIMS through Senior Procurement cum Stores Officer, All India Institute of Medical Sciences, Bhopal for and on behalf of the Director, AIIMS Bhopal.

- a. Proposal for rate contract may be submitted in the prescribed format and all columns may be filled up. Incomplete proposals and tenders received after due date shall not be entertained. [The Institute shall not be responsible for any postal delay and delay in receipt of the offer]. Any bids received on line by the Institute which does not fulfill the desired terms and conditions shall be rejected outrightly and no communication in this regard shall be sent. Delayed / Late Bids will not be accepted, at any circumstances.
- b. Quotations qualified by such vague and indefinite expression such as "Subject to prior confirmation", "Subject to immediate acceptance" etc. will be treated as vague offers and rejected accordingly. Any conditional tender shall be rejected summarily.
- c. The Manufacturers (OEMs) / principals offering for the Rate Contract may furnish the name and address of their **local authorized distributor / dealer**, so that the copies of orders could be endorsed d the principal, the bills raised by dealer stockiest them against our purchase order will be accepted, for payment to them directly
- d. Any addition and deletion of authorized dealership / distributorship shall be intimated to the Institute immediately along with the Name address, and Contact Number of the Newly authourized dealer/Distributor etc.
- e. At any time prior to date of submission of tender, Tender Inviting Authority may, for any reason or decision, modify the terms & conditions of the tender document by a corrigendum displayed on the website of AIIMS Bhopal (<http://www.aiimsbhopal.edu.in>). In order to provide reasonable time to take the amendment into account in preparing their bid, Tender Inviting Authority may or may not, at his discretion, extend the date and time for submission of tenders.
- f. A copy of current rate list duly signed& soft copy in CD will be submitted separately in sealed cover so s to reach one day before the end date for submission of bid.

2. The bidders are required to mention % of GST applicable on each item. Otherwise rates will be treated as inclusive of all taxes.

3. **An undertaking may be given that the rate shown in the rate list will remain valid for the entire duration of rate contract irrespective of validity period, Annexure - V**
4. Trade discount along with certificate certifying that higher discount is not given to any other Department/Organization/Institution than offered should be enclosed with Financial Bid.
5. The percentage of discount quoted by each firm in tenders be given both in words and figures.
6. No equipment, apparatus, is covered under this rate contract.
7. A Certificate to be given by the tendered that the rate list supplied against the tender is the only one in circulation.
8. In case of supply of goods made through valid authorized dealer, **their name & mail address may be declared / indicated in the tender.**
9. **Authorization certificate in respect of foreign firms duly self-attested and showing validity period may be submitted.**
10. Enlistment under Rate Contract with this Institute does not ensure business of any quantum, whatsoever. Any deviation from the Terms & Conditions mentioned above will imply disqualification of the Tenderer.

11. DOCUMENTS COMPRISING THE ONLINE BID:

The bids submitted to online by the bidder shall comprise of (1) Technical Bid and (2) Financial Bid:

1. **Technical Bid:** - To qualify in the Technical Bid the firm should have the minimum eligibility criteria as under and the firm in this regard must submit the following documents in support of their eligibility criteria: -
 - (a) Valid registration certificate of the firm of the Govt. / State Govt.
 - (b) Duly filled format of Technical Bid as per **Annexure-VII**
 - (c) Copy of constitution or legal status of the bidder manufacturer / Sole proprietorship / firm / agency etc.
 - (d) Price list of the items from the Principal, rate list of reagents & consumables of the OEM.
 - (e) PAN Card scanned copy duly attested.
 - (f) GST scanned copy duly attested.
 - (g) The bidder can be a Manufacturer / Distributers / Suppliers / Agents.
 - (h) **Financial Status:** - The annual turnover from similar jobs, of the firm should not be less than ₹. 25 Lakhs average in each of the **last three consecutive years**. Copies of profit & loss account and balance sheets duly authenticate by a Chartered Accountant for the last three years should be enclosed.
 - (i) The technical bid should be accompanied by Demand Draft of **Rs. 89,950/- (Rupees) for EMD.**
 - (j) Copy of Income Tax Return Acknowledgement for last Three years.
 - (k) Copy of Sales tax / GST registration certificate.
 - (l) Details of clients where similar services are presently provided by the tenderer separately for govt.

and private clients.

- (m) The bidder must have experience of execution of similar work in Govt. offices / PSUs / Autonomous Bodies and other similar organizations. Necessary supporting documents like work orders, work completion certificate, payment certificate etc. for last three years to this effect must be submitted along with the offer.
- (n) The concerned firm/company whose product has been declared as of spurious or adulterated quality and any criminal cases is filed and is pending in any court shall not be eligible to participate in the bidding process. Convicted firms/company shall also not be eligible to participate in the bid. Similarly, blacklisted / banned / debarred firms / company by any central / state govt. or its organization or autonomous bodies or central drug procurement agency is not eligible to participate in the bid.
- (o) Brochure, original technical catalogue with detailed specification and picture of the product offered, if relevant.
- (p) The bidder should be having BIS/ FDA/CE or similar quality certification.

2. Financial Bid: (to be submitted online) offline not acceptable. The financial bid shall contain, as per **Annexure -X**

- (a) Price Bid Form – Price must be quoted as per format specified, failing which tender shall be summarily rejected.
- (b) The price quoted will be exclusive of taxes and inclusive of all applicable charges (i.e. packing, forwarding, postage and transportation) at F.O.R. AIIMS Bhopal and shall be fixed and final. Taxes, as applicable will be extra, which will separately quoted in the bid, At the time of payment Income Tax or any other statutory tax shall be deducted at source.
- (c) The offer shall be firm and in Indian Rupees only. No foreign exchange will be made available by the Institute.
- (d) The rate quoted by the bidder shall remain fixed during the entire period of contract and shall not be subject to variation on any account. A bid submitted with an adjustable price quotation will be treated as non-responsive and rejected.

12. Signing of Tender :

Individual signing the tender or other documents connected with contract must specify whether he sign as:

- (a) A sole proprietor of the concern or constituted attorney of such sole proprietor;
- (b) A partner of the firm, if it is a partnership firm in which case he must have authority to execute the contracts on behalf of the firm and to refer to arbitration disputes concerning the business of the partnership either by virtue of the partnership agreement or by a power of attorney duly executed by the partners of the firm.
- (c) Director or a principal officer duly authorized by the Board of Directors of the Company, if it is a company.

13. A person signing the tender form or any document forming part of the tender on behalf of another person should have an authority to bind such other person and if, on enquiry it appears that the person so signing had no authority to do so, AIIMS Bhopal may without prejudice, cancel the contract and hold the signatory liable for all costs, consequences and damages under the civil and criminal remedies available.

14. The tenderer should sign and affix his firm's stamp at each page of the tender and all its annexure as the acceptance of the offer made by tenderer will be deemed as a contract and no separate formal contract will be drawn. **NO PAGE SHOULD BE REMOVED/ DETACHED FROM THIS NOTICE INVITING TENDER.**

15. Online Opening of Tender:

The tenderer is at liberty either himself or authorize not more than one representative to be present at the

opening of the tender. The representative attending the opening of the tender on behalf of the tenderer should bring with him a letter of authority from the tenderer and proof of identification.

16. TECHNICAL EVALUATION:

- a) Detailed technical evaluation shall be carried out by Purchase Committee pursuant to conditions in the tender document to determine the substantial responsiveness of each tender. For this clause, the substantially responsive bid is one that conforms to all the eligibility and terms and condition of the tender without any material deviation. The Institute's determination of bid's responsiveness is to be based on the contents of the bid itself without recourse to extrinsic evidence. The Institute shall evaluate the technical bids also to determine whether they are complete, whether required sureties have been furnished, whether the documents have been properly signed and whether the bids are in order.
- b) The technical evaluation committee may call the responsive bidders for discussion or presentation to facilitate and assess their understanding of the scope of work and its execution. However, the committee shall have sole discretion to call for discussion / presentation.
- c) Financial bids of only those bidders who qualify the technical criteria will be opened provided all other requirements are fulfilled.
- d) AIIMS Bhopal shall have right to accept or reject any or all tenders without assigning any reasons thereof.
- e) AIIMS Bhopal shall reserve the right to ask for free sample of a product to determine its technical suitability, prior to consideration of placement of purchase order. Such rights shall be reserved for entire duration of rate contract.
- f) **Sample/Demonstration: The tenderers may be required to place samples of the consumables (without indicating price, clear marking of firm / agency name in each of item) when required by the Purchase Committee and Concerned Department of All India Institute of Medical Sciences (AIIMS), Bhopal for quality evaluation and in case all the expenses will be borne by the tenderer.** Purchase will be done only after the approval of the quality of the product by the Competent Authority. 18. Right of acceptance:

The AIIMS Bhopal reserve the right to accepting the whole or any part or portion of the bid; and the bidder shall provide the same at the rates quoted. The AIIMS Bhopal reserve the right to reject any or all tenders / quotations or all offers received in response to the tender or cancel or withdraw the tender notice without assigning any reason thereof and also does not bind itself to accept the lowest quotation or any tender and no claim in this regard shall be entertained.

19. Delivery:

Delivery of goods shall be made by the supplier within **28 days** of placing of purchase order, however, in case of emergent requirement he has to supply the required quantity of goods within **1 weeks of placing of order also. In few cases the items are to be delivered at a very short notice i.e. within 24 hours.'**

20. Staggered deliveries:

21. Liquidated Damages

22. Risk Purchase

(a) AWARD OF CONTRACT: PLACE MENT OF ORDER

The Institute shall consider placement of orders for jobs on those bidders whose offers have been found technical, commercially and financially acceptable. The Institute reserves the right to counter offer price(s) against price(s) quoted by any bidder.

(b) Validity of the bids:

The bids shall be valid for a period of **180 days** from the date of opening of the tender. This has to be so specified by the tenderer in the commercial bid.

23. FORCE MAJEURE:

If, at any time during the subsistence of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reasons of any war or hostility, act of public enemy, civil commotion, sabotage, fire, floods, explosion, epidemics, quarantine restriction, strikers lockout or act of God (hereinafter referred to as events) provided notice of happening of any such eventuality is given by party to other within 21 days from the date of occurrence thereof, either party shall by reason of such event be entitled to terminate this contract nor shall either party have any claim for damages against other in respect of such non-performance or delay in performance, and deliveries have been so resumed or not shall be final and conclusive.

Further, that if the performance in whole or in part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days, either party may, at least option to terminate the contract.

24. The Payment clause:

The bill addressed to Director in triplicate may be sent to the office of the SPSO, Central stores for settlement after satisfactorily delivery of the material. The bill should have full particulars of the supply

No payment shall be made in advance nor shall the loan from any bank or financial institutions be recommended on the basis of the order of award of work.

The contractor shall submit the bill only after supply of the material to the satisfaction of the AIIMS Bhopal, on receipt of a pre-receipted bill invoice from the Contractor the case of issuing sanction and passing of bill for payment will be initiated. No payment will be made for goods rejected.

25. Performance Security:

The successful tenderer will be required to furnish **Rs. 28. Subletting of Work:

29. Arbitration:

If attempts for conciliation do not yield any result within a period of 30 days, either of the parties may make a request to the other party for submission of the dispute for decision by an Arbitral Tribunal containing Sole Arbitrator to be appointed by the Director, AIIMS Bhopal. Such requests shall be accompanied with a panel of names of three persons to act as the sole arbitrator. In case of such arbitrator refusing, unwilling or becoming incapable to act or his mandate having been terminated under law, another arbitrator shall be appointed in the same manner from among the panel of three persons to be submitted by the claimant. The provision of Arbitration and Conciliation Act, 1990 and the rule framed there under and in force shall be applicable to such proceedings.

30. Insolvency etc:

In the event of the firm being adjudged insolvent or having a receiver appointed for it by a court or any other order under the Insolvency Act made against them or in the case of a company the passing any resolution or making of any order for winding up, whether voluntary or otherwise, or in the event of the firm failing to comply with any of the conditions herein specified AIIMS Bhopal shall have the power to terminate the contract without any prior notice.

31. Right to call upon information regarding status of work:

The AIIMS Bhopal will have the right to call upon information regarding status of work / job at any point of time.

32. Fall Clause:
